Project Title: Lower Mound Lake Basin Restoration, Blue Mounds State Park

Comment Deadline: April 25, 2018

Project Description: The Minnesota Department of Natural Resources (MN DNR) proposes to address conditions left by natural disasters that occurred between June and July, 2014, which resulted in a failed dam and damages, including the drained basin that was known as Lower Mound Lake, located within Blue Mounds State Park near Luverne, in Rock County, Minnesota. The proposed project includes removal of the remaining structures of the failed dam and restoration of Lower Mound Lake Basin to a natural stream. Public comments will be taken from March 26, 2018 until 4:30 pm April 25, 2018.
