Project Description: trū Shrimp Company is proposing construction of a new harbor facility located in Luverne, Rock County, Minnesota. The complex will include a harbor facility, water engineering center, two hatcheries, maintenance, and electrical facilities. Cumulative square footage of the proposed harbor and ancillary facilities totals 686,941 square feet, with construction occurring over several years (2018-2020).
