## Vadnais Lake Area Water Management Organization (VLAWMO) Bacteria, Nutrient, and Sediment Reduction Project

Comment Deadline: June 17, 2020

**Project Description:** The Vadnais Lake Area Water Management Organization (VLAWMO) received MPCA funding for improvements along County Ditch #14 (Lambert Creek), which is a tributary of the St. Paul Regional Water Services' final impoundment reservoir, East Vadnais Lake. The Project includes sheetpile replacement, a meandered channel, and the addition of biochar treatment cells to address the bacteria impairment. #### Oak Ridge Development

Comment Deadline: June 17, 2020

**Project Description:** The developer is proposing to redevelop land surrounding the existing Oak Ridge Hotel and Conference Center at 1 Oakridge Drive in Chaska, Carver County, MN. The site is approximately 64 acres and currently contains a 171,000 square foot conference center, parking lots, recreation, and undeveloped land. The proposed development includes up to 166,000 square feet of additional commercial use, 498 multifamily/senior housing units, 1,939 proposed parking spaces, and associated infrastructure. The document is available on the City's website. The City of Chaska will accept comments until 4:00 PM on June 17, 2020.
