## **Environmental Assessment Worksheets**

### **Whiskey Creek Enhancement Project**

Comment Deadline: June 25, 2020

**Project Description:** In an attempt to improve water quality, reduce sedimentation, reduce flooding, and improve habitat, the Buffalo-Red River Watershed District proposes to complete channel restoration using natural channel design principles, install expanded buffer strips along Whiskey Creek, and install side culvert inlets and other sediment control BMPs within the Whiskey Creek Watershed. An EAW has been prepared and is available for review on the BRRWD website (<a href="https://www.brrwd.org">www.brrwd.org</a>). Written comments concerning the EAW will be received until June 25, 2020. The comments shall address the accuracy and completeness of the material contained in the EAW, potential impacts that may warrant further investigation before the project is commenced, and the need for an Environmental Impact Statement on the proposed project.

### **Hunter Hills Residential Development**

Comment Deadline: June 25, 2020

**Project Description:** Hunter Hills Residential Development is proposed on 208.15 acres of land in northeastern Wright County. The project will consist of up to 590 residential units, including about 454 single-family detached homes and 136 multi-family attached homes. Site development will include installation of municipal sewer and water, mass grading, and stormwater management features.
