Project Title: Red Rock Quarry Expansion

Comment Deadline: December 11, 2019

Project Description: Red Rock Quarry proposes to expand quarry operations south of its current location (approximate 90-acre site in NE ¼ of Section 12, Amboy Township (T107N, R36W), Cottonwood County, Minnesota). The expansion will require extraction of quartz aggregate from 30 feet to 120 feet below grade. It will utilize open- pit quarrying of quartzite which includes blasting, crushing, dewatering, size classification, and reclamation activities of approximately total acres in part of the EI\2 SW1/4 EX TR; SE1/4 EX TR Section 12, T107N, R36W (Amboy Township), Cottonwood County, Minnesota. Current land use in the expansion area includes row-crop agriculture and natural areas.

Project Title: Cedar Hills Residential Development

Comment Deadline: December 11, 2019

Project Description: The Cedar Hills residential development is proposed on approximately 159.5 acres of primarily agricultural land in the southeastern portion of Lakeville. The project proposes 82 twin homes, 155 villa homes, and 136 single-family homes. Approximately 43.5 acres of open space is also planned, which will include parks, buffers, woodlands, wetlands, and stormwater basins.
