Project Title: Oronoco Regional Wastewater System and Water Distribution

Project Comment Deadline: December 18, 2019

Project Description: The city of Oronoco intends to construct and operate a new wastewater treatment facility that will discharge to the Middle Fork of the Zumbro River immediately downstream of the City. In addition to the wastewater treatment facility, the City will construct sanitary sewer lift stations, install sanitary sewers, install drinking watermains, provide riverbank stabilization along the Zumbro River, and decommission 11 community drain fields and 1 community pond treatment system. Project Title: French Lake Industrial Center AUAR UPDATE

Comment Deadline: December 4, 2019

Project Description: The French Lake Industrial Center Alternative Urban Areawide Review (AUAR) examines 170.9 acres of land in Dayton, MN to analyze the impacts and mitigation measures necessary to accommodate a proposed industrial development. The City of Dayton adopted the French Lake Industrial Center Final AUAR and Mitigation Plan on February 10th of 2015. Since the French Lake Industrial Center study area has not been fully developed, the purpose of this document is to update the AUAR pursuant to Minnesota Rules.
