Hoot Lake Solar Project

Comment Deadline: December 30, 2020

Project Description: Otter Tail Power Company (OTP) is proposing to develop a 49.9megawatt alternating current (MW-AC) solar photovoltaic (PV) project (Project) near OTP's Hoot Lake Plant. The Project would be located on a site partially within the city of Fergus Falls, Minnesota, on approximately 450 acres of OTP-acquired lands that were previously primarily in agriculture. OTP is in the process of petitioning the City to annex the portion of the Project currently outside the City. Upon completion of the annexation process, the solar facility will be completely within city limits. The Project would include approximately 150,000 PV solar modules laid out in rows in a north-south orientation.


