### **Lock and Dam 2 Protective Island Project**

Comment Deadline: November 12, 2020

**Project Description:** The U.S. Army Corps of Engineers, St. Paul District is proposing to protect the Lock and Dam 2 embankment from erosion through construction of an offshore protective island. The island would result in a variety of unique habitat types that are not currently present above the Lock and Dam 2 embankment. Some of these habitat types include; wooded/forest, brush/grassland, beach, fish overwintering and emergent wetlands. The island would be constructed with sediments dredged from the Mississippi River.

## Scoping EAW and Draft Scoping Decision Document

### **Grindstone Dam Removal Project**

Comment Deadline: November 12, 2020

**Project Description:** The Minnesota Department of Natural Resources (DNR) is seeking public comments on the scoping documents for a State Environmental Impact Statement (EIS). The EIS will describe the potential environmental effects of a proposed dam removal project in the Hinckley area. The scoping documents provide information about the topics that are proposed to be included in the State EIS for the proposed project. The DNR proposes to remove the dam on the Grindstone River in Hinckley and restore connectivity to the river channel. This would result in the permanent removal of the 26.6-acre Grindstone Reservoir, which is a public water basin. The removal is proposed because the dam is in poor condition, it presents a safety hazard, and it is a barrier to passage of fish and other aquatic wildlife on the river. The dam also does not allow for natural sediment transport and natural stream features or habitat diversity.

Comments received at these meetings will inform the EIS scoping process. People do not need to attend a meeting to comment. Comments may also be submitted in writing as outlined above. The DNR will respond to comments when it issues a Final Scoping Decision Document (FSDD). The FSDD determines what will be included in the State EIS. The most helpful comments are those that directly address the content of the scoping documents and offer specific suggestions for inclusion in the scope of the State EIS. The DNR will then prepare a Draft EIS that will be made available for public comment. Another public information meeting will be held during that comment period. People who submit comments will receive a copy of the decision document, which will include responses to comments. Because all comments and related information are part of the public record for this environmental review, commenters'

names and email or postal addresses will also be published and publicly available as they appear in the materials they submit.

**Public Meeting Details:** An online informational meeting and comment opportunity will be held from 6 p.m. to 7:30 p.m. Thursday, Nov. 5, with an in-person option for up to six individuals without a device or internet connection, at that same time. The EIS scoping documents include a Scoping Environmental Assessment Worksheet (SEAW) and a Draft Scoping Decision Document (DSDD).

**Online Public Input Session:** The DNR invites interested people to an online public information meeting. The meeting will provide details about the project and the EIS scoping process, followed by a public input session.

**How to attend the online meeting:** All are welcome to join the online meeting from 6 p.m. to 7:30 p.m. Thursday, Nov. 5, on their computer, smartphone or landline phone. A WebEx link is required and is available on the project webpage.

How to attend if I don't have reliable computer or phone access? In order to provide accommodations for individuals without a device or adequate internet connection, the DNR will host a space during the meeting time where connected computers and technical assistance will be provided. Computers will be set up at the Hinckley Community Room, 106 1st Street Southeast, Hinckley, MN, from 6 p.m. to 7:30 p.m. Thursday, Nov. 5. Computer reservations are required by 2 p.m. Wednesday, Nov. 4. Instructions will be provided after registration confirmation. Space is limited to six people, to comply with State social distancing guidance.
