### Environmental Assessment Worksheets

#### Stony Creek Water Resource Management Project (WRMP)

Comment Deadline: November 18, 2020

**Project Description:** The Buffalo-Red River Watershed District (BRRWD) proposes the development of the Stony Creek Water Resource Management Project (WRMP) located in Clay County, Minnesota. The project requires an Environmental Assessment Worksheet (EAW) because work will change or diminish the course, current, or cross-section of one acre or more of a public water (Subp. 27) and the channel restoration will cause the realignment of more than 500 feet of the natural watercourse (Subp. 26). Project components along Stony Creek (Clay County Ditch No. 31) include the establishment of expanded permanent vegetated buffers, pushing back existing setback levees, the installation of sediment control best management practices (BMPs), stream restoration, and the construction of an off-channel floodwater impoundment. The project is located in Sections 2, 3, 4, 5, 9, 10, 11, 12, and 13 of Barnesville Township, Clay County. The project is a cooperative undertaking between the BRRWD, the Clay Soil and Water Conservation District, State, and Federal agencies.

The establishment of Nelson Lake Outlet (Proposed Project), located two miles west of Parkers Prairie, Otter Tail county, MN, will provide an adequate outlet to address the rising water level that is impacting county roads and adjacent private property.

#### **Ponds Behind Erie Pier Sediment Remediation**

Comment Deadline: November 18, 2020

**Project Description:** The Minnesota Pollution Control Agency, in partnership with the United States Environmental Protection Agency and the United States Army Corps of Engineers, will hire a contractor to conduct environmental cleanup in the Ponds Behind Erie Pier in the St. Louis River Area of Concern. The remedial work consists of dredging approximately 45,000 cubic yards of contaminated sediments, temporarily storing and dewatering the sediments on site, disposing of the dewatered sediments at a certified off-site landfill, placing a residual cover of clean sediment over the dredged area, and revegetating the site post construction.

## **General Notice**

### Metropolitan Airports Commission Assessment of Environmental Effects 7-Year Capital Improvement Program 2021-2027

Minnesota Statutes, Section 473.614 requires the Metropolitan Airports Commission (MAC) to prepare an Assessment of Environmental Effects (AOEE) for projects in the Commission's seven-year Capital Improvement Program (CIP) 2021-2027 for airports included in its system. An Environmental Assessment Worksheet, Environmental Assessment or Environmental Impact Study has been previously completed and a public hearing held for each Minneapolis-St. Paul International Airport (MSP) and reliever airport project in the 2021-2027 CIP as required under Section 473.614. An assessment of the cumulative environmental effects of CIP projects at each affected airport in the system is presented in the AOEE. A copy of the AOEE document, titled Assessment of Environmental Effects - Seven Year Capital Improvement Program – 2021 to 2027, may be downloaded on or after October 19, 2020, online: https://metroairports.org/airport-authority/metrpolitan-airportscommission/administration/publications.
