# **Project Title: Parkway Residences**

Comment Deadline: November 20, 2019

**Project Description:** Environmental Assessment Worksheet available for review and comment St. Louis Park, Minn. – On October, 7, 2019, the City of St. Louis Park approved release of an Environmental Assessment Worksheet (EAW) for the proposed Parkway Residences redevelopment. The development is located in St. Louis Park, Minnesota, along both sides of 31st Street West between Inglewood Avenue South

and Glenhurst Avenue South. The development will remove 12 of the existing buildings and will reinvest in the rehabilitation of three apartment buildings with 24 units. The development will also construct four new multi-family buildings with 224 new units for a combined total of 248 residential units. The development plan segments the project into four campuses to be built in phases: west campus, north campus, southwest campus and southeast campus plus the three existing apartment buildings to remain.

The City of St. Louis Park is the Responsible Government Unit (RGU) for review of the mandatory Environmental Assessment Worksheet (EAW). The St. Louis Park City Council approved the EAW for distribution on October 7, 2019.
