Public Utilities Commission (Commission) – Notice of Public Hearing for the power plant siting and transmission line routing annual hearing. This hearing is conducted in accordance with Minnesota Statute § 216E.07. The Commission is providing notice that it will hold the Public Hearing at 10 AM on November 14, 2018 in the Commission's Large Hearing Room at 121 7th Place East, 3rd Floor, St. Paul, MN 55101.

Administrative Law Judge Kimberly Middendorf will preside over the hearing. Commission and Department of Commerce staff will give an overview of the programs and projects pending or

completed in 2018. Staff will also be available to answer questions. Judge Middendorf will use the information gathered at the hearing to write a summary report for the Commission. Members of the public will have the opportunity to offer oral or written comments, or both, into the record. No comments on specific projects are being considered at the annual hearing.

Notice of Public Meeting and Comment Period for the Fenton Wind Repowering Project in Murray and Nobles Counties

Public Utilities Commission (Commission) – Notice of Public Meeting for the Fenton Wind Repowering Project in Murray and Nobles Counties, Commission Docket No. IP-6499/WS-05-1707. The Commission is providing notice that it will hold a Public Meeting on the proposed project at 6 PM on November 15, 2018 at Tally Ho Koffie/Gray Wolf at 130 Howard St. E., Edgerton, MN 56128.

Fenton Power Partners I, LLC (Fenton Wind) is proposing to retrofit existing wind turbines by retrofitting turbine equipment. There are no changes proposed to the turbine locations or towers. Fenton Wind is requesting permit amendments to: increase the rotor diameter, the output of the turbines, and the project nameplate capacity, to extend the permit expiration date and adjust permitted setbacks.
