Project Title: Middle Sand Creek Corridor Restoration Project, Coon Rapids MN

Comment Deadline: November 6, 2019

Project Description: A combination of bank stabilization and natural channel design methods will be employed along a 3/4-mile reach of Sand Creek to address aquatic life impairments by improving stream stability and enhancing in-stream and riparian habitat. Work includes channel re-shaping, floodplain excavation, native plant restoration, and installation of vegetated riprap, toe wood, root wads, and j-hooks.

Project Title: METRO Gold Line Bus Rapid Transit Project

Comment Deadline: November 6, 2019

Project Description: The Metropolitan Council (Council) and the Federal Transit Administration (FTA) have issued an Environmental Assessment (EA)/Environmental Assessment Worksheet (EAW) for the METRO Gold Line Bus Rapid Transit (BRT) Project. Gold Line BRT is a proposed nine- or ten-mile bus rapid transit line that will connect Saint Paul, Maplewood, Landfall, Oakdale and Woodbury with bus-only lanes generally north of and near Interstate 94. Gold Line is proposed to provide 21 full-amenity stations and frequent all-day service, seven days a week.

The Environmental Assessment evaluates potential environmental, social, economic and transportation benefits and impacts from the project's construction and operations. Upon consideration of the comments received on the EA/EAW, the FTA and the Council will determine the adequacy of the environmental document. If further documentation is necessary, preparing an Environmental Impact Statement (EIS), revising the EA/EAW, or providing clarification in the Findings of Fact and Conclusions would accomplish

this. If an EIS is not necessary, the Council will prepare a Negative Declaration on the need for an EIS to fulfill Minnesota state environmental requirements. Further, if, upon consideration of comments received on the EA/EAW, the FTA agrees with the Council's findings, the FTA will issue a Finding of No Significant Impact.

Comments on the accuracy and completeness of the information, potential impacts that may warrant further investigation before the project is commenced, and the need for an EIS on the project are being accepted through November 6, 2019.
