Project Title: Randy Hein Swine Facility

Description: Randy Hein is proposing an expansion of an existing swine finishing facility in Section 28 of Graham Lake Township in Nobles County. The facility currently has a maximum physical capacity of 2, 400 finishing hogs, or 720 animal units, housed in one barn. The proposed facility expansion will consist of the construction of one additional barn that will have a maximum physical capacity of 2, 400 finishing hogs. After construction, the maximum physical capacity of the entire facility will be 4,800 finishing swine (1,440 animal units). The existing and proposed barns will be total confinement, power-ventilated buildings. Manure will be stored in reinforced concrete pits located beneath each of the barns.

SUMMARY: The Minnesota Department of Transportation is issuing this notice to advise the public that the Environmental Impact Statement (EIS) process for proposed highway improvements to Trunk Highway (TH) 14 from the City of Rochester to the City of Eyota in Olmsted County Minnesota is terminated.

Mn/DOT, in cooperation with the Federal Highway Administration, has terminated the EIS process begun in 2002 to address safety, operational, structural and geometric deficiencies on approximately eight miles of TH 14 from the end of the four-lane roadway on the east side of Rochester through Eyota, in Olmsted County Minnesota. The Scoping Decision Document for the project was approved by Mn/DOT on October 1, 2003. On December 18, 2003, Mn/DOT notified federal, state and local agencies through the Minnesota Environmental Quality Board's Distribution List that funding constraints have resulted in a delay in proceeding with the environmental review process for the project.

At such time when funding is available to proceed with the project, the results of the scoping process will be reviewed and updated, as appropriate. Therefore, the EIS for this project has been terminated.

SUMMARY: The Minnesota Department of Transportation is issuing this notice to advise the public that the Environmental Impact Statement (EIS) process for proposed highway improvements to Trunk Highway (TH) 10 in the vicinity of the City of Wadena (in Wadena and Otter Tail Counties), Minnesota is terminated. Mn/DOT, in cooperation with the Federal Highway Administration (FHWA), has terminated the EIS process begun in 2001 to address transportation demand, access management, and interregional corridor status on TH 10 from 3.3 miles west of the intersection with US Highway 71 to 2.8 miles east of the Highway 71 intersection. The Scoping Decision for this project was issued in May, 2004 (notice was published in the EQB Monitor on May 10, 2004) and work on the Draft EIS was initiated. In the Matter of the Application of Xcel Energy for a Route Permit for the Mary Lake 115 kV Transmission Project

PUC Docket Number: E002/TL-07-1365

On September 17, 2008, the Minnesota Public Utilities Commission adopted findings of fact and issued an Order determining that the Environmental Assessment prepared for Xcel Energy's proposed Mary Lake 115 kV Transmission Project was adequate. The Order also designated a route and issued a route permit to Xcel Energy for the project. The route is located entirely in Wright County and connects the Buffalo Power – Maple Lake 69 kV transmission line and the Mary Lake – Dickinson Junction 69 kV transmission line, a total distance of approximately 5 miles. The route parallels existing road rights of way for approximately 90 percent of the length.

The project is intended to improve electric reliability to the Buffalo area by providing additional capacity to the existing Buffalo Power – Maple Lake 69 kV transmission line. Xcel Energy anticipates that the Project will address reliability issues related to the transmission system until approximately 2034.

PLEASE TAKE NOTICE that Wisconsin Power and Light Company (WPL) has applied to the Minnesota Public Utilities Commission (PUC) for a Certificate of Need (CON) for a Large Wind Energy Conversion System (LWECS) of up to 400 megawatts (MW), a CON for a 161 kilovolt High Voltage Transmission Line (HVTL), and a Site Permit for the LWECS. The LWECS and the HVTL will be located in Freeborn County and together are called the Bent Tree Wind Project (Project).

Public Information Meeting/Open House Dates

The Minnesota Office of Energy Security (OES), Energy Facilities Permitting Staff (EFP) will hold information meetings on WPL's applications for the LWECS Site Permit [and Certificates of Need for the LWECS and HVTL]. A public information and Environmental Report (ER) scoping meeting will be held at the locations specified below. EFP staff will prepare an ER on the Project. EFP staff will also review the state's permitting process for LWECS and HVTLs and how the public may be involved. In conjunction with the EFP staff information meetings, WPL will hold an open house prior to each public information meeting to answer questions and provide the public with information about the project.

Project Description

The Project includes a LWECS of up to 400 MW, expected to come on line in two phases of 200 MW each. WPL currently proposes to construct the first 200 MW, comprising of 80-133 utility-scale wind turbine generators with a capacity between 1.5 and 2.5 MW each and associated facilities including access roads, meteorological towers, communications lines, and power lines. The Project is located in northwest Freeborn County, in south central Minnesota, approximately 4 miles northwest of Albert Lea, Minnesota (see attached map). Electricity from the Project will be transported to the existing Hayward Substation located east of Albert Lea, Minnesota via a 161 kilovolt (kV) HVTL, approximately 18-miles long.

PUC Review Process

Four approvals are required to build a LWECS larger than 50 MW and a HVTL. A project developer must obtain a CON under Minnesota Statute 216B.243 for the LWECS and the HVTL and a Site Permit under Minnesota Statutes Chapter 216F for the LWECS and a Route Permit under Minnesota Statutes Chapter 216E for the HVTL.

WPL filed its CON application for the LWECS and the HVTL on June 27, 2008, and its Site Permit application for the LWECS on June 20, 2008. The PUC accepted the CON applications on August 27, 2008; The PUC accepted the LWECS site permit application and issued a draft Site Permit on September 16, 2008. The applications and draft Site Permit are available from the web site and persons listed below. Landowners and governments inside the LWECS boundary will receive a copy of the Site Permit application directly from WPL. The HVTL Route Permit Application will be filed by WPL at a later date.

The EFP staff is responsible for conducting public meetings on the site permit application and environmental review of the CON application under Minnesota Rule 7849.7050. The EFP staff will prepare an ER prior to CON public hearing and the PUC's determination of Project need. The ER will consider issues related to the CON, such as size, type, timing, voltage, and system configurations, and the general environmental impacts of the Project. The EFP staff is also responsible for conducting the public participation process for the Site Permit application. Environmental review for the Site Permit is addressed in the Site Permit Application. Human, social, and environmental impacts raised in public comments may be addressed by adding or modifying specific conditions in the Draft Site Permit.

After completion of the ER, the PUC will hold a public hearing on the CON application, presided over by an Administrative Law Judge from the Office of Administrative Hearings. Under Minnesota law, the CON proceeding is the only time at which the "no-build" alternative and the size, type, and timing of a new electrical generating facility can be considered. These items will not be addressed in the Site Permit process. The proposed HVTL cannot be constructed unless the PUC certifies that it is needed. Certification of a HVTL is governed by Minnesota law, including specifically chapter 7849, parts 7849.0010 to 7849.0400 and 7849.7010 to 7849.7110, and Minnesota Statutes, section 216B.243. Notice of the public hearing will be published in local newspapers and mailed to persons who register their names on the Project mailing list with the OES EFP staff. Persons interested in adding their names to this mailing list should contact the OES project manager or register at the webpage address provided below.

Public Comment Period

The OES will accept written comments on the Site Permit application, and suggested alternatives to be evaluated in the ER, until December 3, 2008. Any person may request a contested case hearing on the Site Permit application during the comment period pursuant to Minnesota Rule 7836.0900. Written comments and

Upon completion of the public participation and hearing process, the records compiled in each proceeding will be presented to the PUC for final decisions on the applications.

Eminent Domain for the Bent Tree Site Permit

WPL does not currently have the power of eminent domain to acquire the land or wind rights for the LWECS. WPL will work with landowners to purchase wind and land rights in the form of voluntary easements or lease agreements. Eminent domain is governed by Minnesota Statute Chapter 117 and 216E.12.

Eminent Domain for the HVTL

WPL cannot construct the transmission line without a route permit issued by the PUC. Typically, 161 kV transmission lines use wood or steel poles that are 80 to 100 feet tall and spaced about 300 to 600 feet apart within a right-of-way that is about 80 feet wide. If the Commission approves the need for the HVTL and WPL subsequently obtains the permit necessary to construct the transmission line, WPL will work with landowners to purchase property rights, known as an easement, in order to construct the transmission lines. WPL does not currently have the power of eminent domain; eminent domain is governed by Minnesota Statute Chapter 117 and 216E.12.
