Project Title: The Harbor at Tower

Description: The Environmental Assessment (EA) is available for the Harbor at Tower Project, which involves a mixed-use development situated around a reconstructed harbor and navigationally improved riverfront on the East Two River located in the City of Towner, St. Louis County. Infrastructure improvements include reconstructing the Highway 169 Bridge, realignment of Highway 135, dredging and widening the existing harbor, dredging the East Two River, replacing river channel sheet piling, constructing a jetty in Lake Vermilion, and other local street, utility, and pedestrian features.

Copies of the Harbor at Tower EA are being distributed to those agencies on the current MEQB document review list and others. Project Title: Marathon Petroleum, LLC Rail Yard Project

Description: Marathon Petroleum Company, LLC (Marathon) is proposing to construct a new, fenced rail yard immediately adjacent to the existing Canadian Pacific Railway (CPR) St. Paul Rail Yard in the city of St. Paul. The proposed rail yard will be used to store up to a maximum of 170 empty, semi-full, or full railcars, which will have product storage capability of approximately 8.4 million gallons of liquid petroleum gas, asphalt, and ethanol. Empty rail cars will have previously contained asphalt, roofing flux, caustic, and sulfur. The proposed rail yard will be located on CPR property, and Marathon will lease the property from CPR.

In the Matter of the Route Permit Application for the South Bend to Stoney Creek 115 kV High Voltage Transmission Line and Substations Project

PLEASE TAKE NOTICE that the Minnesota Department of Commerce Office of Energy Security (OES) will conduct a public information and Environmental Assessment scoping meeting, at the time and location listed below, on the route permit application by Great River Energy and Xcel Energy to the Minnesota Public Utilities Commission (PUC or Commission) for the proposed South Bend to Stoney Creek project in Rapidan and

Mankato Townships. The purpose of the meeting is to provide information to the public about the project and to identify issues and route alternatives to study in an Environmental Assessment that will be prepared by the OES Energy Facility Permitting (EFP) staff.

The public information meeting will follow an open house format until 6:00 p.m., when EFP staff will give a presentation about the state's high voltage transmission line alternative permitting process, the proposed project, and how the public may be involved. The applicant will have representatives at the public meeting who can answer general questions about the proposed project.

Review copies of the route permit application, a flow chart depicting the alternative permitting process, and comment forms will be available at the public information meeting.

Project Description

The Project includes the following components of a 69-kilovolt (kV) transmission line that would be rebuilt within the existing easement to a 115 kV transmission line to loop around Mankato.

- Two new substations: 115-161/69 kV South Bend Substation and 115/69 kV substation and a 69 kV breaker station at Stoney Creek
- Approximately four miles of an existing NSP-Minnesota 69 kV transmission line will be rebuilt to 115 kV from South Bend Substation to Ballard Corner switches.
- Approximately two miles of an existing NSP-Minnesota 69 kV transmission line will be rebuilt to 115/69 kV double-circuits from Ballard Corner switches to Stoney Creek Substation.
- Approximate two miles of an existing NSP-Minnesota and Great River Energy 69 kV transmission line will be rebuilt to 115 kV from the Stoney Creek Substation to the Pohl Substation.

The proposed facilities would require substation and equipment upgrades at the Eastwood and Wilmarth substations to accommodate the upgraded transmission facilities.

Review Process

A route permit application for the project was filed by Great River Energy and Xcel Energy on August 7, 2008. The application was accepted as complete by the Commission on September 15, 2008.

Applications for high voltage transmission line route permits are subject to environmental review, which is conducted by EFP staff. The staff is herein providing notice and will conduct a public information and scoping meeting to solicit public comments on the scope of the environmental assessment. The Director of the OES will ultimately determine the final scope of the environmental assessment. The environmental assessment will address issues related to routing, such as construction impacts, environmental features, use of existing rights-of-way, impacts on homes and businesses, and consideration of public comments.

Applications for high voltage transmission line route permits require a public hearing upon completion of the environmental assessment. Notice of the hearing will be published in local newspapers and mailed to persons who register their names on the project mailing list. At least a portion of the public hearing will be held in Blue Earth County where the proposed project would be located.

Should the Commission issue a route permit, in accordance with its authority under state law, Great River Energy and Xcel Energy may, if necessary, exercise the power of eminent domain in this matter.
