Project Title: Castle Rock Materials Sciota Quarry

Project Description: The Project is an expansion of an existing aggregates mine. Activities associated with the mining operation include stripping topsoil and overburden, blasting, excavation of sand and gravel and limestone, processing, including crushing, washing and screening, stockpiling, loading and site reclamation. The Project encompasses an existing 80 acre parcel with 34 acres permitted for mining. The expansion adds 80 acres to the site and increases the mining area to 129 acres.

Project Title: Quarry Creek Stabilization Project

Project Description: Scott County proposes to stabilize erosion in a ravine system using a combination of runoff detention, grade control, and streambank treatments. Extreme rainfall in recent years has generated so much sediment that the bridge at County Road 6 has been

blocked multiple times. This causes road closures and maintenance costs. This project is located in Blakeley Township (T113N, R25W, sec. 3 & 10), Scott County, Minnesota.

Project Description: Knife River is proposing to expand the existing Liechty Pit from 30 to 88 acres of a 121 acre parcel. This non-metallic mineral mine produces sand and gravel. It is located in the Southeast Quarter, Section 25-141-46, Clay County, MN.

Project Title: St. Francis Wastewater Treatment Facility

Project Description: The existing St. Francis Wastewater Facility will be modified by constructing a new influent lift station and constructing a new treatment facility in the footprint of the existing secondary pond. The existing lift station building will be modified to house the influent valves and piping. Biosolids generated during the treatment of the wastewater will be stored onsite and land applied on the existing permitted land application sites. The existing blower building will be kept for air supply to the existing ponds. The Permittee is proposing to increase the average wet weather design flow discharge to Seelye Brook from 0.54 million gallons per day (mgd) to 0.81 mgd. The city will also be removing and properly closing its outfall to the Rum River, an Outstanding Resource Value Water.

The Permittee is proposing to increase the average wet weather design flow from 0.54 mgd to 0.814 mgd, and to eliminate the discharge outfall to the Rum River.

Project Title: Metropolitan Council Environmental Services Seneca Area Collection System Rehabilitation -Phases 3, 4, and 5

Project Description: The Metropolitan Council Environmental Services (MCES) will be replacing or rehabilitating 31,000 feet of wastewater pipe in the portion of the MCES sewer collection system located within the city of Burnsville. The collection system conveys wastewater to the MCES Seneca Wastewater Treatment Facility (Seneca WWTF) which is located in Eagan, Minnesota. The collection system is over 50 years old and present significant defects and potential for failure within the next 20 years. The work is to be done in three phases (Phases 3, 4, and 5). The work in Phases 3 and 4 will also address future wastewater capacity needs.

Draft Alternative Urban Areawide Review

Comment Deadline: May 27, 2015

Project Title: Draft Elko New Market Alternative Urban Areawide Review

Project Description: As the Responsible Governmental Unit (RGU), the City of Elko New Market has prepared a Draft Alternative Urban Areawide Review (AUAR) for proposed development east of the City and Interstate 35 (I-35). The 265-acre environmental study area includes a proposed light industrial project, the Ryan Companies Development, which is planned for subarea parcels subject to an orderly annexation agreement and totaling 125 acres.

Development Boundaries and Scenarios: Because the AUAR addresses a large project (the Ryan Companies Development), which on its own would trigger an Environmental Impact Statement, a Scoping AUAR was required. The purpose of the Scoping AUAR was to solicit comment on the development boundary and scenarios to be evaluated in the AUAR, prior to issuance of a final AUAR order. A notice of the Scoping AUAR was published in the EQB Monitor on February 2, 2015, and copies of the document were placed in the Technology and Science Library, the Elko New Market City Hall and Public Library, and the New Market Township Hall. The deadline for comments was March 4. Based upon the written comments received, the City of Elko New Market has prepared a Draft AUAR.

The development boundaries of the 265-acre AUAR study area include the proposed 125-acre Ryan Companies Development and 140 acres in surrounding parcels with potential for more commercial/light industrial development. The scale of the anticipated light industrial and commercial development ranges from maximums of 1.50M square feet in 2016 (at opening) up to 2.84M square feet by 2036.
