The project will include the following major items: Grading, Aggregate Base, Bituminous Surfacing, Aggregate Shouldering, Culvert Replacement, Storm Sewer, Curb & Gutter, Sidewalk, and Lighting.

Project Description: Curt Schilling (Proposer) proposes to expand his existing 2,400 head, swine finishing facility in Section 34 of Grand Prairie Township in Nobles County (Facility). Project Title: Weaver Bottoms Aquatic Habitat Restoration/Enhancement Project

Project Description: The Minnesota Department of Natural Resources is proposing to restore and enhance aquatic habitat in Weaver Bottoms, a backwater area of Pool 5 of the Mississippi River in Wabasha County. The project will restore depth to a natural floodplain lake that has become filled with fine sediments over the past 80 years after navigation dams were built on the Upper Mississippi River. Sediment from approximately 20 acres of shallow water will be mechanically dredged and then trucked approximately 1/3 mile to be deposited at a ten-acre upland site on privately owned agricultural/pasture land. The MDNR will accept written comments on the Environmental Assessment Worksheet during the public review and comment period, which concludes Wednesday, September 16, 2015, at 4:30 p.m.

Notice of Environmental Impact Statement (EIS) Preparation

Project Title: Detroit Lakes Becker County Airport Runway Improvements

The City of Detroit Lakes will prepare a combined Federal Environmental Assessment (EA) / State Environmental Impact Statement (EIS) for proposed improvements at Detroit Lakes – Becker County Airport (FAA identifier DTL). The proposed action for the project is expected to include the following:

- A shift, extension, widening, and reconstruction of the Airport's primary runway and parallel taxiway to meet FAA and MnDOT design standards and operator runway length requirements;
- Reconstruction of the primary runway to replace aging and deteriorating pavement;
- An instrument approach to the Airport's primary runway with precision CAT-I minimums (1/2 statute mile visibility and 200-foot cloud ceiling height) to meet MnDOT State Aviation System Plan (SASP) requirements; and
- · Property acquisition to accommodate the runway and approach improvements.

A Final Scoping Decision Document (FSDD) for the proposed Airport improvements has been issued by the City of Detroit Lakes. The FSDD will be sent to the EQB distribution list and other interested parties, and will be posted on the City's website. The FSDD describes the purpose of and need for the proposed action; identifies alternatives to be developed and evaluated for the EA/EIS; and methods that will be used to study the potential environmental, economic, and social impacts of the proposed action. The FSDD takes into account agency and public comments received during the project scoping process and comment period from May 25 to July 9, 2015.
