## **Project Title: Faribault Foods Relocation and Expansion**

**Project Description:** The Faribault Foods Relocation and Expansion project includes the conversion of 57.03 acres of fallow agricultural/vacant industrial land use to warehouse/manufacturing use. The project location is between Park Avenue NW (County Road 76) and the Canadian Pacific Railway in Sections 13 and 24 of the City of Faribault, Rice County, Minnesota. Development of the proposed project will total 589,600 square feet for manufacturing, storage, and offices. Construction is anticipated to take place from 2016-2020. One additional future expansion after 2020, totaling 23,041 square feet, is planned for processing and storage.

The EAW may be viewed at City Hall in the Community and Economic Development Department or the Faribault Public Library. It also may be available on the City's website or the City Planner can email a PDF of the EAW to interested parties. The City Planning Commission will review the EAW at its January 4, 2016 meeting.

# **Project Title: Meadowbrook Golf Course and Minnehaha Creek Improvements**

**Project Description:** The Minneapolis Park and Recreation Board, in partnership with the Minnehaha Creek Watershed District, is proposing to make improvements to the Meadowbrook Golf Course, including re-meandering of Minnehaha Creek on golf course property. The project will address flooding issues on the property by maintaining the current volume of floodplain storage and increasing the effective length of Minnehaha Creek within the site, while increasing the amount of natural vegetation and habitat.

The Minneapolis Park and Recreation Board (MPRB), comprised of nine elected commissioners, serves as an independently elected, semi-autonomous body responsible for governing, maintaining, and developing the Minneapolis Park System. MPRB, in partnership with the Minnehaha Creek Watershed District, is proposing to make improvements to the Meadowbrook Golf Course, located in Cities of Hopkins, St. Louis Park, and Edina, Hennepin County, Minnesota. Proposed improvements include golf course modifications and remeandering of Minnehaha Creek on golf course property. Due to project activities associated with Minnehaha Creek, a mandatory Environmental Assessment Worksheet (EAW) is required per Minnesota Rules 4410.4300. The MPRB will accept written comments on the EAW during the public review and comment period, which concludes Wednesday, January 6, 2016 at 4:30 p.m. The EAW is posted on the MPRB's website at <a href="https://www.minneapolisparks.org">www.minneapolisparks.org</a>.

## **Project Title: Traxler Construction Inc. Gravel Mine Expansion**

**Project Description:** The project is an expansion of an existing sand and gravel mine in Le Sueur County. The expansion parcel is located across Minnesota Trunk Highway (MTH) 112 from the existing mine and processing plant. The total acreage of parcels with existing and proposed mining and processing activities is 152.92 acres. The expansion site will encompass 78 acres, of which no more than 49.3 acres will be mined. Mining involves the removal of overburden, excavation, crushing and screening and conveying the material. Mining will remove overburden to expose gravel, then the gravel will be conveyed under the highway for

additional processing, stockpiling and sales at the existing processing plant. Reclamation will be concurrent with mining.

The public is invited to comment on the draft EAW. The comment period for the Draft EAW will begin on December 7, 2015. ## **Project Title: Kraus-Anderson Block Redevelopment**

**Project Description:** The proposed mixed-use project would result in the redevelopment of an approximate two and one-half acre site along Portland Avenue in Downtown Minneapolis, between South 8th and 9th Streets known as the KA Block. The project is anticipated to be developed in one phase and would provide at completion up to 306 dwelling units, a 148-unit hotel and associated restaurant/bar, 107,000 square feet of office, a 12,000 square-foot brewery, a 13,000 square foot event center, and up to 530 off-street parking spaces.

Copies of the EAW will be available for review at the downtown Minneapolis Central Library located at 300 Nicollet Mall, and in the office of the City's CPED, Land Use, Design and Preservation Section at 250 S. 4th Street, Room 300 Public Service Center. Notice will be published in the EQB Monitor on Monday, December 7th, 2015. Public comments on the EAW must be made within the 30-day comment period, which ends at 4:30 p.m. on Wednesday, January 6th, 2016. It is anticipated that the Zoning and Planning Committee at its regular meeting on February 4, 2016, or at a subsequent meeting, will receive a report and recommendation from City staff, hear comment from all parties and consider the adequacy of this EAW and the need for an Environmental Impact Statement for this proposal. The City Council will act on the recommendation of this Committee at a subsequent meeting on February 12, 2016.

# Transgenic Corn Rootworm Resistant and Glyphosate Tolerant Corn - Commercial Use Exemption Application

Monsanto has requested an exemption from the Minnesota Department of Agriculture's Genetically Engineered Organism Release Permit for a corn event designated as MON 87411 which has been genetically modified to be resistant to corn rootworm and tolerant to the herbicide glyphosate. A determination of non-regulated status has been issued by USDA, it has been registered with USEPA as a Plant Incorporated Pesticide (PIP), and the FDA consultation process has been completed.
