# **Project Title: Rebco Pork II**

**Project Description:** Rebco Pork, Inc. (Proposer) proposes to build two 102 feet x 204 feet total confinement buildings with 10 feet deep concrete manure storage pits below the buildings, along with a 20 feet x 48 feet composting building in Section 12 of Courtland Township, Nicollet County (Project). The proposed facility will house up to 4,800 market swine for a total of 1,440 animal units (AUs).

# Notice of SDEIS Public Comment Period Extension

# **Project Title: Southwest Light Rail Transit**

**Project Description:** The Supplemental Draft Environmental Impact Statement (EIS) describes the transportation and environmental impacts associated with the construction of the approximately 16-mile Southwest Light Rail Transit (LRT) (METRO Green Line Extension) project as an extension of the METRO Green Line (Central Corridor LRT). The Southwest LRT would operate from downtown Minneapolis through the communities of St. Louis Park, Hopkins, Minnetonka, and Eden Prairie, passing in close proximity to Edina.

On May 22, 2015, The U.S. Department of Transportation, Federal Transit Administration (FTA) published a notice of availability in the Federal Register for the Supplemental Draft Environmental Impact Statement for the Southwest Light Rail Transit Project for public review and comment. That notice stated that the public review and comment period would conclude on July 6, 2015. On May 25, 2015, a notice of availability for the Supplemental Draft Environmental Impact Statement was published in the EQB Monitor with the incorrect public comment deadline of June 24, 2015. On May 29, 2015, a full notice of availability was published in the EQB Monitor with the corrected initial public comment deadline of July 6, 2015.

The FTA and Metropolitan Council have since decided to extend the public comment period in response to requests from corridor stakeholders. The public comment period is extended from July 6, 2015 to July 21, 2015. No additional public hearings will be held.

## Notice of Public Hearing and Comment Period: Minnesota Public Utilities Commission Investigation into Environmental and Socioeconomic Costs Under Minn. Stat. § 216B.2422, Subd. 3

Office of Administrative Hearings (OAH) Docket Number: 80-2500-31888 and Minnesota Public Utilities (MPUC) Docket Number E-999/CI-14-643

**Project Description:** The MPUC is providing notice of a public hearing and comment period regarding its reopened investigation into the environmental costs of four specific pollutants: carbon dioxide (CO2), particulate matter less than 2.5 microns in diameter (PM2.5), sulfur dioxide (SO2), and nitrogen oxides (NOX). In 1997, as required under <u>Minnesota Statute §</u> <u>216B.2422</u>, <u>Subdivision 3</u>, the MPUC established environmental costs of different methods of generating electricity. Starting in 2001, the values were increased each year to account for inflation.

The Commission has reopened this investigation which is focused on three technical questions.

- 1. Is the Federal Social Cost of Carbon reasonable and is it the best measure to determine the environmental cost of carbon dioxide (CO2)?
- 2. If not, what measure is better and why?
- 3. What are the appropriate environmental cost values for particulate matter less than 2.5 microns in diameter (PM2.5), sulfur dioxide (SO2), and nitrogen oxides (NOX) and why?
