Project Title: Goose Prairie Marsh Enhancement Project

Project Description: The Goose Prairie Marsh Enhancement Project proposes changes to improve management of surface waters near Goose Prairie Marsh in Clay County. The project would include installation of a water control structure, raising 115th Ave N, realignment of CD 18 from the marsh to the water control structure, and selective repair of CD 18 downstream of the new control structure. This is a joint project between the Minnesota Department of Natural Resources (MN DNR) and the Wild Rice Watershed District (WRWD). The agency will accept written comments on the Environmental Assessment Worksheet during the public review and comment period, which concludes Wednesday, December 23, 2015, at 4:30 p.m.

NOTICE OF HEARING

NICK FIECKE ("Fiecke") IS HEREBY NOTIFIED that the Department of Natural Resources ("DNR") has initiated this action pursuant to Fiecke's appeal of DNR's Restoration Order 884631 issued to Fiecke.

ORDER FOR PREHEARING CONFERENCE

ORDER FOR HEARING

IT IS FURTHER ORDERED that a contested case hearing in this matter will be held at a time and place to be decided by the Administrative Law Judge at the prehearing conference.

ALLEGATIONS

- Respondent owns the real property located at 1751 N. Ketelle Dr. NE, Osakis, MN 56360 (the "Property").
- On February 19, 2015, the DNR issued Restoration Order #884631 (the "Restoration Order") to Respondent. A copy of the Restoration Order is attached as Exhibit A.
- The DNR issued the Restoration Order after investigating suspected use of herbicide to control emergent vegetation and cattail within Lake Osakis adjacent and riparian to the Property.
- 4. Staff from the Minnesota Department of Agriculture collected samples of the affected vegetation in October 2014 and analyses showed that the cattail and vegetation had been sprayed with a glyphosate-based herbicide.
- The DNR's conservation officers initially estimated a loss of 5400 square feet of emergent aquatic vegetation in the area of Lake Osakis adjacent and riparian to the Property.
- Respondent did not have an aquatic plant management permit required by Minn.
 Stat. § 103G.615 and Minn. R. 6280.0250, subp. 2 to spray or remove cattail or vegetation in the waters adjacent to the Property.
- 7. Minn. Stat. § 103G.615, subd. 4(b) authorizes the DNR to require restoration or replacement of any emergent or floating leaf vegetation lost as a result of the illegal destruction of aquatic vegetation in public waters to the condition existing before the illegal activities were undertaken.
 - 8. The Restoration Order required Respondent to:
 - Allow natural re-growth of cattail within the area of affected vegetation
 adjacent to the Property;

- Apply for a permit to transplant cattail stems and plant cattails in the area of destruction in a stem density of at least 2 stems per square foot;
- c. If transplant and replanting efforts are unsuccessful in restoring cattail to an average stem density of 5 stems per square foot by August 15, 2015, replanting of additional cattail will be rquired; and
- d. Restore cattail in the area adjacent to the Property along 120 feet of lakeshore by 45 feet lakeward below the ordinary high water level to a density of 5 stems per square foot by August 15, 2016.
- On March 19, 2015, Respondent appealed the Restoration Order to the Commissioner of the DNR for review pursuant to Minn. Stat. § 103G.615, subd. 4(c).
 Respondent questioned the amount of area of cattail required to be restored under the Restoration Order.
- 10. On May 13, 2015, the Commissioner's designee informed Respondent that he had concluded the review under Minn. Stat. § 103G.615, subd. 4(c) and determined that the issuance of the Restoration Order was consistent with Minn. Stat. § 103G.615 and Minn. R. ch. 6280.

 The Commissioner's designee requested DNR staff to re-measure the site and size of the area to be restored and amend the Restoration Order accordingly.
- On June 16, 2015, an Aquatic Plant Management Specialist with the DNR revisited the site and measured the area of destruction in the public waters adjacent to the Property.
- 12. On July 16, 2015, the Commissioner's designee sent a letter to Respondent informing him of the results of the June 16th review and re-measurement. The letter advised Respondent that the area required for restoration under the Restoration Order was estimated to be

2,945 square feet. This July 16th letter incorrectly advised Respondent that the restoration had to be completed by August 15, 2015.

 On August 28, 2015, the DNR sent a letter to Respondent advising him of the error in the July 16th correspondence and confirmed that the deadline for restoration under the Restoration Order was August 15, 2016.

 Respondent submitted a timely request for contested case hearing of the Restoration Order as amended.

ISSUES

1. Whether the DNR may enforce the Restoration Order, as amended, and require Respondent to restore 2,945 square feet of emergent vegetation in the area of Lake Osakis adjacent to the Property?

The relevant laws and rules include, but are not limited to, Minn. Stat. §§ 103G.615, .311, and .315; and Minn. R. 6280.0250.
