Issues Before the Board

The Board will be asked to approve the EQB cover memo and summary of member responses.

Background

At the August 17, 2006 meeting, the Board agreed to assist the new Legislative Citizen Commission on Minnesota Resources by coordinating agency responses to four questions posed by Representative Tingelstad. The questions were:

- What are the pressing natural resources issues for your agency?
- What are your recommendations to enhance and/or preserve natural resources and address the issues identified?
- What priorities are identified in each agency's strategic plans for the management of natural resources?
- What past projects funded through the Trust Fund or Future Resources Fund have made a major impact on how the agency has managed natural resources?

Board staff developed a schedule and set of response guidelines, and hosted a discussion session with agency representatives. Six agencies responded, including Agriculture, Health, Natural Resources, Pollution Control, Transportation and Water & Soil Resources. Staff developed the proposed draft Board response after consultation with agency representatives. The document describes several common themes from the agency responses and draws heavily upon the responses to highlight issues.

Significant Issues

LCCMR staff has notified us that they need to receive the EQB and member agency responses as soon as possible after the September Board meeting, since the Commission plans to discuss the responses at a meeting on September 28.

V. Minnesota Campaign for Conservation Informational Presentation

Issue before the Board

Background

As they state on their Web page (see http://www.campaignforconservation.org/), the Minnesota Campaign for Conservation is a coalition of citizens and organizations committed to developing long term conservation strategies, funding sources and policy tools that will ensure the preservation of Minnesota's cherished outdoor traditions for future generations. The campaign

recently issued *Minnesota Calling: Conservation Facts, Trends and Challenges*, which lays out conservation issues related to population growth and land use, and puts out a call for Minnesotans to come together "to assure our conservation future."

The Board may want to explore in the coming months whether and how it might collaborate with the Campaign for Conservation.
