### Project Title: Kelly Aggregate, Inc.

**Description:** The Kelly Aggregate, Inc. project includes extracting and processing aggregates from both above and below groundwater from a 79.85 acre area, part of a 155.53 acre property. Mining activity includes stripping, extraction, processing, and stockpiling of aggregate, recycling of concrete and asphalt, and subsequent site reclamation, all of which will be done in phases.

#### Project Title: Cedar Avenue Corridor Transitway Environment Assessment

**Description:** The Environmental Assessment (EA) is available for the portion of the Cedar Avenue Corridor Transitway which extends between 138<sup>th</sup> Street and County Highway 70 in the cities of Apple Valley and Lakeville in Dakota County, Minnesota. The proposed improvements include construction of shoulder-running Bus Rapid Transit (BRT) lanes, additional northbound and southbound lanes between 153<sup>rd</sup> Street and 160<sup>th</sup> Street, and several access modifications.

# **EIS PREPARATION NOTICE**

### Project Title: Keetac Mine Expansion Project - St. Louis and Itasca Counties, Minnesota

The Department of Natural Resources (DNR) will prepare a joint state-federal Environmental Impact Statement (EIS) for the Keetac Mine Expansion Project. This project includes expanding an open-pit mine, re-starting an idle indurating line and upgrading of plant components. The project proposer is U. S. Steel Corporation. The proposed project is located north of the City of Keewatin on the border of St. Louis and Itasca counties. The U. S. Army Corps of Engineers (USACE) is the lead federal agency for the EIS.

The DNR distributed a Scoping Environmental Assessment Worksheet (EAW) and Draft Scoping Decision Document on September 8, 2008 to all agencies listed on the Environmental Quality Board (EQB) distribution list, adjacent landowners and all interested parties. Availability of the Scoping EAW and Draft Scoping Decision Document were noticed in the September 8, 2008 *EQB Monitor* (Vol. 32, No. 18). The DNR held a public scoping meeting in Nashwauk, Minnesota, and accepted comments during a 30-day public comment period concluding on October 8, 2008.

The DNR and USACE considered comments on the proposed scope, made revisions to the Draft Scoping Decision Document, and issued a Final Scoping Decision Document on November 5, 2008. The Scoping Decision identifies those project alternatives and issues that will be addressed in the EIS and presents a tentative schedule for EIS completion.

**Summary of Scoping Decision.** The EIS will address the following issues: land uses; cover types; waterrelated land use management districts; erosion and sedimentation; surface water runoff; geologic hazards and soil conditions; solid wastes, hazardous wastes and storage tanks; traffic; odors, noise and dust; historic resources, farmland and trails; visual impacts; impact on infrastructure and public services; mineral fibers; fish and wildlife; state-listed (endangered, threatened or special concern) species, rare plant communities or other sensitive ecological resources; physical impacts on water resources; wastewaters; air source emissions, human health risk assessment; and potential cumulative effects including: the use of biomass as a fuel source; aquatic habitat and fisheries; mercury deposition and bioaccumulation in fish; wildlife habitat; threatened and endangered species and species of special concern; streamflow and lake level changes; inter-basin transfer of water, loss of wetlands; water use, visibility impairments in Class I areas; ecosystem acidification; effects on human and ecological health; climate change; and economic and social impacts. The EIS will evaluate the following alternatives:

**Proposed Alternative.** This project includes expanding an open-pit mine, re-starting an idle indurating line and upgrading of plant components. Waste rock stockpile areas would expand. The tailings basin would grow vertically and the footprint would increase slightly. One or more tailings thickeners would be added. Additional haul trucks, shovels and other equipment would be purchased and used. The crude ore storage building would be expanded. Additional water would be used. New air emissions control technologies would be added as well as plant energy efficiency technologies.

**No Action Alternative.** The EIS will describe the expected condition if the proposed project is not developed and the Keetac Mine continues operating without expansion.

Alternative Technologies. The EIS will evaluate the following alternative technologies:

- Air Emissions Control Technologies (Best Available Control Technologies), and
- Mercury Air Emissions control technologies.
- Greenhouse Gas Emissions

Site Design and Layout. The EIS will evaluate the following alternative site designs and layouts:

- Waste Rock Stockpile locations, and
- New snowmobile trails locations if trails are displaced.

**Incorporation of Mitigation Measures.** The EIS will consider the mitigations suggested through public comment.

**EIS Schedule.** The tentative EIS schedule includes Draft EIS publication in April 2009, Final EIS publication in July 2008, and determination of EIS adequacy in August 2008.
