Project Title: Edina-Richfield Interceptor Improvements Project

Description: The Metropolitan Council Environmental Services proposes to add gravity interceptor capacity and further address reliability and redundancy in the gravity interceptor serving Edina and Richfield. The proposed interceptor will generally follow the 75th Street corridor west of I-35W and the 76th Street corridor from I-35W to Cedar Avenue in Richfield, Minnesota. The ultimate capacity of this interceptor will be nine million gallons per day.

Project Title: Wright CSAH 19 Improvement Project

Description: The proposed project will reconstruct Wright County State Aid Highway (CSAH) 19 from a two lane urban roadway section in the City of St. Michael to a four-lane urban roadway section with a continuous center turn lane. A raised center median will be constructed at the intersections with Trunk Highway 241/CSAH 35 and Birch Avenue/Frankfort Parkway. The proposed project will also include stormwater pond construction and sidewalk construction.

RECLAMATION PROJECT PLANNED FOR LAKE DNR DIVISION OF FISH & WILDLIFE

The DNR Division of Fish & Wildlife is planning one Muskie rearing pond reclamation project this winter. The project involves the application of rotenone, a federal and state registered pesticide. Heble Pond is proposed to be treated for the purpose of removing existing fathead minnow and other unwanted fish populations. This alteration will allow the pond to be used for raising Muskie fingerlings, which will later be stocked into local fishing lakes. Rotenone will be used with a target concentration of 3.0 ppm.

Large Electric Power Generating Plant Site Application Great River Energy's Elk River Peaking Station Project PUC Docket No. ET2/GS-07-715

PLEASE TAKE NOTICE that the Minnesota Department of Commerce (DOC) announces the availability of the Final Environmental Impact Statement (FEIS) for the Elk River Peaking Stations Project (PUC Docket ET2/GS-07-715).

Project Description. The proposed project consists of a single, simple-cycle combustion turbine (CT) generator with a nominal summer generating capacity of 175 MW and other associated facilities. The facility will use natural gas and ultra-low sulfur distillate fuel oil. The preferred project site is on GRE's campus in Elk River, Sherburne County, Minnesota. The Elk River campus currently includes the Elk River Station, a Refuse-Derived-Fuel (RDF) combustor that co-produces electricity, and GRE's corporate offices. The preferred site is an area of approximately 11 acres in the northeast portion of the campus.

The alternative site is located on GRE's property in the city of Rosemount in Dakota County, Minnesota. The site is bordered on the south by County Highway 42, on the east by Emery Avenue, on the north by Ehler's Path and 140th Street, and to the west by Rich Valley Golf Club. The property is currently leased to a farmer for crop production.

Background: May 18, 2007, Great River Energy (GRE) submitted an application for a Certificate of Need (CON) for the proposed Elk River Peaking Station. The PUC issued an Order finding the CON application to be substantially complete on June 19, 2007. The docket number for this filing is ET2/CN-07-678.

On June 14, 2007, GRE submitted an application for a Site Permit for the proposed Elk River Peaking Station. The PUC issued an Order finding the Site Permit application to be complete on August 1, 2007, and authorized the Department to initiate the full review process under Minn. Rules 7845.5010 to .6500. The docket number for this filing is ET2/GS-07-715.

The Draft EIS was released on November 21, 2007.

Public meetings on the DEIS and the contested case hearing for this docket were held on December 19 and December 20, 2007, at the Rosemount and Elk River city halls, respectively.

Regulatory Review Process. In accordance with the Power Plant Siting Act (Minnesota Statutes, 216E.001 through 216E.18) a site permit is required before a large electric power generating plant (LEPGP) can be constructed. The power plant siting act requirement became law in 1973. The rules to implement the

permitting requirement for LEPGP are in Minnesota Rules Chapter 7849.5010 through 7849.6500. A LEPGP is defined as any electric power generating equipment and associated facilities designed for or capable of operation at a capacity of 50,000 kilowatts or more.

GRE's LEPGP site permit application is being reviewed under the Full Review Process (Minnesota Rule Chapter 7849.5200) within the Power Plant Siting Act. Under the full permitting process the applicant is required to submit two sites (i.e., a preferred and an alternate) for consideration. As part of the permitting process, the Department of Commerce is responsible for certain procedural requirements (i.e., public notice and meetings), issuing the EIS Scoping Decision and the preparation of an Environmental Impact Statement (EIS). A contested case hearing will also be conducted following completion of the draft EIS. The PUC will make the final decision; that decision includes a determination on the adequacy of the FEIS and the determination whether to grant the requested permits, as well as, site selection and permit conditions.
