### **Project Title: Presbyterian Homes Redevelopment**

**Description:** The project site currently includes the Broadmoor Apartments with detached garages, the Castle Ridge Care Center, associated surface parking lots, and two vacant lots (Exhibit 6-1). Development is proposed to include commercial (restaurants, bank, drugstore, retail stores), combined commercial/residential, a senior housing complex with an associated town center and care center, an all-age market rate housing complex, and surface and below-ground parking on 22.09 acres (Exhibit 6-2). Development is proposed to include up to 707 units including skilled nursing, memory care, assisted living, independent senior housing, all-age housing, and affordable senior housing.

Project Title: Montrose Alternative Urban Areawide Review

**Description:** The Montrose AUAR area consists of approximately 5,300 developable acres of future development surrounding the city of Montrose. It is proposed to include low, medium and high density residential, industrial and commercial development. The project includes construction of roads, homes, businesses, trails, parks, ponds, and utilities such as storm water, wastewater, and water supply piping. This AUAR also analyzes the impacts of approximately 1,700 acres of development that exists or is in a various stage of approval and 100 acres of railroad right-of-way, for a total analysis area of approximately 7,100 acres.

**PLEASE TAKE NOTICE** that PlainStates Energy, on behalf of Glacial Ridge Wind Project, LLC, has applied to the Minnesota Public Utilities Commission (PUC) for a site permit to build and operate up to a 20 Megawatt (MW) large wind energy conversion system (LWECS) west of Brooten, Minnesota. The PUC accepted the site permit applications and issued a draft site permit on September 6, 2007.

The Minnesota Department of Commerce (DOC) Energy Facilities Permitting (EFP) staff will host a public information meeting at the date, time and location above to provide an overview of the proposed Project, the wind energy site permitting process and the PUC issued draft site permit for the Project. The public information meeting and a comment period will provide the public an opportunity to ask questions about and make comments on the Project, the process and the draft site permit.

Representatives of DOC and Glacial Ridge Wind Project, LLC, will be at the meeting to describe the proposed Project and answer questions.

### **Project Description**

The Glacial Ridge Wind Project proposes to build eight Nordex N90, 2.5 MW wind turbine generators mounted on freestanding tubular steel towers. The towers will be 80 meters (262 feet) in height measured at the hub. The rotor diameter will be 90 meters (295 feet). The maximum overall height of the wind turbines will be approximately 125 meters (410 feet) above grade when one blade is in the vertical position.

An electrical system consisting of underground and overhead 34.5 kilovolt (kV) collection and feeder lines will deliver power to a Project substation to be built adjacent to the Great River Energy Williams Substation in Gilchrist Township, Section 12. Other associated facilities will include pad mounted step-up transformers and turbine access roads.

### **Proposed Site Location**

The Project site is located in southeastern Pope County in portions of Chippewa Falls, Bangor, Gilchrist and Lake Johanna townships. Glacial Ridge Wind Project, LLC, has obtained wind development rights from landowners for approximately 670 acres within the Project boundary.

### **MPUC Site Permit Review Process**

PlainStates Energy filed a site permit application for the Glacial Ridge Wind Project with the PUC on August 7, 2007 and an amended application on September 5, 2007. On September 6, 2007, the PUC accepted the applications as complete, made a preliminary determination that a permit may be issued and issued a draft site

permit. The application and draft site permit are available from the web site and contacts listed below. Landowners and governments within the Project boundary will receive a copy of the application directly from Glacial Ridge Wind Project, LLC.

The DOC is now initiating the public participation process under the Wind Siting Act (Minnesota Statutes Chapter 216F) and the Wind Permitting Rules (Minnesota Rules Chapter 7836). Upon completion of the public participation process, the DOC will present the record of this matter to the PUC for a final permit decision.

### **Contested Case Hearing Request**

Any person may request a contested case hearing in this matter. Minnesota Rule 7836.0900. All contested case hearing requests must be filed with the Department of Commerce in writing by 4:30 p.m. on **October 24, 2007**. The person requesting the contested case hearing must list the issues to be addressed in the hearing and the reasons why a contested case hearing is required to resolve those issues. The PUC shall order a contested case hearing if it finds that a material issue of fact has been raised and that the holding of the hearing will aid the PUC in making a final decision on the site permit application and draft site permit.
