Project Title: Wayzata Bay Center Redevelopment

Description: The project proposes redevelopment of the 13.95-acre Wayzata Bay Center into a mixed-use retail, office, hotel, and residential complex. The project would include approximately 414 housing units, half senior, half conventional and approximately 140,000 square feet of retail space. An additional 30,000 square feet of office space is contemplated, as well as 80 to 100 hotel rooms. If the hotel is included it will displace about 45 conventional housing units. If the office space is not included it would be replaced by about 20 conventional housing units. The project also proposes innovative approaches for storing and treating stormwater beneath the internal street system.

FINAL EIS ADEQUACY DETERMINATION

Project Title: County State Aid Highway (CSAH) 21 Extension and Transit Station Project

Scott County prepared an Environmental Impact Statement (EIS) for the CSAH 21 Extension and Transit Station Project.

A Scoping Document (SD)/Draft Scoping Decision Document (DSDD) was prepared to identify the issues and alternatives that would be addressed in the EIS. A notice of availability of the SD/DSDD was published in the EQB *Monitor* on April 28, 2003. A public meeting to obtain input on the SD/DSDD was held on May 21, 2003. A Final Scoping Decision Document (SDD) was issued on July 22, 2003, and published in the EQB *Monitor* on August 4, 2003. The EIS Preparation Notice was published in the EQB *Monitor* August 4, 2003.

A Draft EIS was prepared to address the issues and alternatives raised in scoping and identify reasonable mitigation measures for identified adverse effects. The Draft EIS notice of availability was published in the EQB *Monitor* on August 28, 2006. A public hearing was held on September 21, 2006, and comments were accepted on the Draft EIS through October 16, 2006. The comment period was subsequently extended to November 20, 2006, and notice of the extension was published in the EQB *Monitor* on October 23, 2006.

Scott County prepared a Final EIS, which included all comments received during the Draft EIS review period. The Final EIS notice of availability was published in the EQB *Monitor* on December 31, 2007. Scott County accepted written comments on the adequacy of the Final EIS through February 4, 2008.

On March 25, 2008, pursuant to the criteria prescribed in Minnesota rules part 4410.2800, subpart 4, the Scott County Board of Commissioners by resolution determined the Final EIS is adequate. A notice of the adequacy determination was distributed to all parties receiving copies of the Final EIS.

The ER addresses potential human and environmental impacts of the proposed high voltage transmission lines (HVTL) project and alternatives. PROJECT DESCRIPTION

The proposed transmission lines would connect substations in the following locations:

- A 250-mile line between Fargo, North Dakota, and Monticello.
- A 200-mile line from a substation near Brookings, South Dakota, to a new substation near Hampton; plus a related line between Marshall and Granite Falls.
- A 150-mile line running from a new substation near Hampton to Rochester and continuing to La Crosse, Wisconsin.

These transmission lines are part of a longer-term plan intended to strengthen the transmission network to meet demand for electrical power anticipated in Minnesota and parts of surrounding states by 2020 and to increase access to renewable energy sources. In addition, the project is intended to address community service reliability concerns in several communities including Rochester, St. Cloud, the Alexandria area and the Red River Valley.

Specific routes that the transmission lines would follow, if approved, have not yet been proposed by the CapX 2020 utilities. The transmission line routes will be reviewed through a separate PUC permitting process expected to begin sometime in 2008.

PUC CERTIFICATE OF NEED REVIEW PROCESS

The Project is a "large energy facility" as defined in Minnesota Statute 216B.2421, subp. 2 and a Certificate of Need from the Public Utilities Commission is required for such a project under Minnesota Statute 216B.243. On August 16, 2007, Xcel Energy and Great River Energy filed a Certificate of Need application for the project.

The Office of Energy Security Energy Facility Permitting Unit prepares an Environmental Review for Certificate of Need proceedings before the Public Utilities Commission, as per Minnesota Rules 7849.7010-7100.

Public hearings will be held across the state in June (notice will be mailed separately). Under state law, this PUC proceeding is the only time at which the "no-build" alternative and the size, type, and timing of a new

generating facility will be considered. These items will not be addressed in any subsequent PUC Site Permit process.
