### Project Title: Cold Spring Granite Company Mixed Use Development

### Project Title: John Perschbacher Hog Farm

**Description:** The total proposed project will include one 2,400-head (720 animal units) and two 2,000-head (600 animal units each) wean to finish swine buildings located on two sites located approximately 1.15 miles apart. Site 1, which will contain one 2,400-head building, is located in Section 12 of Alden Township in Freeborn County. Site 2, which will contain two 2,000-head buildings, is located in Section 10 of Alden Township in Freeborn County. The buildings will be total confinement, naturally ventilated barns. All barns will have under barn reinforced concrete manure storage. Manure will be sold and land applied by injection at agronomic rates to cropland. The total number of animal units proposed for the two sites is 1,920.

# DRAFT AUAR AVAILABLE

### Project Title: Potlatch West Baxter AUAR

**Description:** The AUAR is comprised of approximately 465 acres of land owned by the Potlatch Corporation. The project area is located on the western end of Baxter, MN and is dissected by Trunk Highway 210.

The AUAR evaluates two land use scenarios. Each land use scenario has been derived from existing plans and studies completed for the City of Baxter, Crow Wing County and the Potlatch Corporation. Scenario One explores a variety of low to high density housing, neighborhood commercial services and industrial uses with an

integrated system of passive and active open space. This scenario serves as the full build out or worse case scenario. Scenario two was developed according to existing zoning regulations.

The full build out scenario includes residential (roughly 1,147 units), commercial, industrial and office development (roughly 1.9 million square feet of space) and includes associated public infrastructure improvements including sanitary sewer, storm sewer, public water supply and roadway/traffic improvements to serve the development. The project is expected to develop over a 20 or more year time frame.

# FINAL AUAR ADOPTED

The City of Eden Prairie has completed its review and adoption of the 2008 Updated Final AUAR for UnitedHealth Group (aka Mixed Use Development in Eden Prairie). The project consists of 1,140,000 sq. ft. of office, 324 housing units, 125-room hotel/restaurant, and 25,000 square feet of retail uses on a 71-acre site located at the southeast corner of TH 62 and Shady Oak Road in Eden Prairie, MN.

The City Council adopted Resolution No. 2008-55 on May 20, 2008, finding the AUAR and mitigation plan accurate, complete, and adequate to prevent significant environmental impacts.

## **EIS PREPARATION NOTICE**

### **Proposed Nelson Mine Expansion Project Cottage Grove, Washington County, Minnesota**

The City of Cottage Grove has reached a Scoping Decision regarding Aggregate Industries' proposal to expand their Nelson Mine at 11250 Grey Cloud Trail, Cottage Grove, MN. This decision follows the distribution of a Scoping Environmental Assessment Worksheet (EAW) and Draft Scoping Decision Document on April 16, 2008, to all agencies listed on the Environmental Quality Board (EQB) distribution list and all interested parties. Availability of the Scoping EAW and Draft Scoping Decision Document were noticed in the April 21, 2008 (Vol. 32, No. 8) *EQB Monitor*. The City of Cottage Grove held a public scoping meeting at the City of Cottage Grove City Hall on May 15, 2008, and accepted comments during a 30-day public comment period concluding on May 21, 2008.

Based upon the Scoping Decision Document, the City of Cottage Grove will prepare an Environmental Impact Statement (EIS) for the proposed Nelson Mine Expansion project. The City of Cottage Grove considered comments on the proposed scope, made revisions to the Draft Scoping Decision Document, and issued a Final Scoping Decision Document on June 4, 2008. The Scoping Decision identifies those project alternatives and issues that will be addressed in the EIS and presents a tentative schedule for EIS completion. The tentative EIS schedule includes publication of a Draft EIS in summer of 2009, Final EIS publication in fall 2009, and determination of EIS adequacy in December 2009.

The EIS will address the physical properties of the backwater area and the immediate surroundings. The EIS will draw upon the previous studies in this area and, to the extent that agency and stakeholders' concerns are not answered by the previous studies, expanded or new studies will be conducted to assess the following areas of potential impact: wildlife, ecologically sensitive resources; physical impacts on water resources; water use; water quality, localized streambed alterations, floodplain impacts, wetland impacts, surface water disturbances, sedimentation resulting from disturbance and resuspension of river bottom sediments, sedimentation and turbidity issues during construction of the barrier dikes, turbidity and nutrient loading caused by the project, impacts on Spring Lake and Lake Pepin with regard to the TMDL; potential for thermal stratification, anoxia and fish kills, and noise and dust issues.

On the Application of Xcel Energy for a Route Permit for the Lake Yankton to Marshall Transmission Line Project in Lyon County

**PLEASE TAKE NOTICE** that the Minnesota Department of Commerce (DOC), Office of Energy Security (OES) will hold a public hearing on behalf of the Minnesota Public Utilities Commission (PUC or the Commission) on the route permit application by Xcel Energy to construct a new 115 kilovolt (kV) transmission line between the Lake Yankton Substation in Balaton to the Southwest Marshall Substation in Marshall, a distance of approximately 15 miles.

**Project Description.** Xcel Energy proposes to build an approximately 15-mile, 115 kV volt high voltage transmission line (HVTL). The proposed route would primarily run parallel along existing public roads and transmission lines from the existing Lake Yankton Substation to the existing Southwest Marshall Substation.

**Environmental Assessment.** The OES has completed an environmental assessment (EA) on the proposed project. The environmental assessment addresses the potential human and environmental impacts of the proposed route. The environmental assessment and other documents relevant to the route permit process are available for review and download on the PUC website <a href="http://energyfacilities.puc.state.mn.us/Docket.html?Id=19448">http://energyfacilities.puc.state.mn.us/Docket.html?Id=19448</a> or by contacting the OES staff listed below.

**Conduct of Hearing.** The purpose of the public hearing is to compile the record for the PUC to consider in making a final decision on the route permit application. Upon closure of the public comment period, Judge Mihalchick will provide a written summary of testimony given at the hearing to the DOC. The PUC will make a final decision on the route permit application at a subsequent meeting.

The public hearing will be conducted in accordance with the requirements of the Power Plant Siting Act, Minnesota Statutes 216E.01 to 216E.18, and Minnesota Rules 7849.5500 to 7849.5720. The Honorable Steve Mihalchick, Administrative Law Judge, will preside over the hearing.

OES staff will be present at the hearing to make a brief presentation describing the project, explain the process to be followed, and to introduce documents to be included in the record; including the application, the environmental assessment, and relevant procedural documents. Representatives from Xcel Energy will be present to introduce evidence by way of testimony and exhibits and to answer questions. Members of the public will have an opportunity to ask questions of OES staff and Xcel Energy representatives, to make oral statements/presentations, and to offer written comments and documents into the record. Members of the public are not required to file any papers in advance of the hearing in order to participate.

The record will remain open until **4:30 p.m., July 11, 2008**, for interested persons to submit written comments to the Administrative Law Judge. Comments must be submitted directly to:
