#### Project Title: Rochester Phase 3 NE Trunk Sanitary Sewer Relief Line

#### Project Title: Trunk Highway 10 Third-Lane Addition Project, City of Coon Rapids, Anoka County

**Description:** The Minnesota Department of Transportation is proposing to add a third lane in each direction in the center median of Trunk Highway (TH) 10 from Egret Boulevard to Hanson Boulevard in the City of Coon Rapids. The project is approximately 1.4 miles in length and will result in a six-lane freeway facility. In addition, two bridges over the Burlington Northern/Santa Fe railroad tracks will be replaced.

# EIS ADEQUACY DECISION

The Minnesota Department of Transportation (Mn/DOT) announces the completion of the Record of Decision and Adequacy for the Highway 23 Bypass around Paynesville.

A Record of Decision is the environmental decision document, issued by the Federal Highway Administration (FHWA), which explains the reasons for the project decision and summarizes any mitigation measures that will be incorporated into the project. Completion of the Record of Decision marks the conclusion of the Federal environmental review process and allows a major project to proceed to detail design, right of way acquisition, letting and construction.

**PLEASE TAKE NOTICE** that on April 1, 2008, Wapsipinicon Wind Project, LLC (Applicant) filed an application for a certificate of need (CN) for the Wapsipinicon North Wind project, a large (105 MW) energy facility as defined under Minn. Stat. § 216B.2421, subd. 2(1). Under Minn. Stat. § 216B.243 a large energy facility cannot be constructed in Minnesota unless it receives a certificate from the Commission. The rules governing the review of this project are found in Minnesota Rules Chapter 7849.

A site permit for the Wapsipinicon project (Docket No. IP6646/WS-07-839) has already been reviewed and approved. The permit for the North Wind project area is being held pending a resolution of the CN process.

An Environmental Report (ER) on the project and alternatives to it is being conducted by the Energy Facilities Permitting (EFP) unit of the Minnesota Office of Energy Security (OES) under Minnesota Rule 7849.7010-7110. A public information and ER scoping meeting will be held at the time and location listed below:

Thursday, July 10, 2008 6:00 p.m. Elkton Community Center Building 117 Main Street Elkton, MN 55926

The purpose of the public meeting is to provide information to the public about the proposed Project and to take public comment and suggestions on the scope of the ER that will be prepared for the CN application. The public is invited to review the application, learn about the PUC review process, and make comments and ask questions.

#### **Project Description**

The Applicant would own, construct, and operate the Project. The Project would have a nameplate capacity of up to 105 MW and consist of up to seventy 1.5 MW wind turbine generators. The towers will be 80 meters (262.5 feet) in height. The rotor diameter will be 77 meters (252.6 feet), resulting in a maximum overall height of 118.5 meters (388.8 feet) when one blade is in the vertical position.

The electrical collector system will consist of underground 34.5 kV collection lines and facilities providing step-up transformation. The Applicant is also proposing to build a 161/34.5 kV project substation which will consist generally of 2 161/34.5 transformers, and associated switching and protection equipment as well as metering equipment and a small control house.

Power from the turbines will be collected at this substation and transmitted to the Pleasant Valley Substation located in section 19 of Pleasant Valley Township via approximately 6 miles of overhead 161 kV transmission line.

Other Project associated facilities will include pad mounted step-up transformers and access roads.

#### **Proposed Site Location**

As shown on the accompanying map, The Project will be located in central Mower County, near the town of Dexter, in portions of Grand Meadow, Pleasant Valley, Dexter and Sargeant townships, and approximately 20 miles east of Austin, Minnesota. The Applicant has designated approximately 40 square miles as the Project area. The town of Dexter is adjacent to the Project site to the Southwest. Interstate 90 is the southern border of the Project area.

#### **PUC Review Process**

An LWECS project over 50 MW must obtain a Certificate of Need from the PUC. The Applicant filed its CN Application on April 1, 2008. On May 21, 2008, the PUC accepted the CN as complete, given the Applicant's filing of supplemental materials.

The OES EFP unit is responsible for conducting public meetings and environmental review of the CN Application under Minnesota Rule 4410.7030. OES will prepare an Environmental Report prior to the public hearing for the CN and the PUC's determination of need for Wapsipinicon North Wind Project. The ER will consider issues related to the CN for the Project, such as size, type, timing, voltage and system configurations and general environmental impacts of the Project. Under state law, the CN proceeding is the only time at which the "no-build" alternative and the size, type and timing of a new electrical generating facility can be considered.

The PUC will hold a public hearing on the CN application which will be presided over by an Administrative Law Judge from the Office of Administrative Hearings. Notice of the CN public hearing will be published in local newspapers and mailed to persons who register their names on the project mailing list with the OES. Persons interested in adding their names to this mailing list should contact the OES project manager or register on the webpage cited below.

# DRAFT SITE PERMIT AVAILABLE For the Proposed Sibley County Wind Project MPUC Docket No. IP6666/WS-08-208

**PLEASE TAKE NOTICE** that Sibley Wind Substation, LLC, has applied to the Minnesota Public Utilities Commission (PUC) for a site permit to build and operate up to a 20 Megawatt (MW) large wind energy conversion system (LWECS) west of Winthrop, Minnesota.

The Minnesota Department of Commerce (DOC), Office of Energy Security (OES) will hold a public information meeting at 6:30 p.m. on Tuesday, July 15, 2008, at the Winthrop Vets Club. The meeting will provide an overview of the state's wind energy site permitting process and the proposed draft site permit for the Sibley County Wind Project. The public information meeting and a comment period will provide the public an opportunity to ask questions about and make comments on the Project, the process and the draft site permit. Representatives of the OES and Sibley Wind Substation, LLC, will be at the meeting to describe the proposed Project and answer questions.

Prior to the public information meeting, the applicant will host an open house beginning at 5:30 p.m. The applicant's representatives will be available at the open house to discuss the project and answer questions.

#### **Project Description**

The Applicant is considering three possible wind turbine generators for the Project. Depending upon the turbine model selected, the Applicant proposes to install 10-13 wind turbine generators and anticipates an inservice date of no later than December 2010. The proposed turbines would use 80 meter (262 feet) tubular towers measured at the hub height. Depending upon the model selected, the rotor diameter of the turbines would be 225 - 288 feet, with a maximum overall height of approximately 375 - 406 feet above grade when one blade is in the vertical position.

Energy from the Project will be delivered to the Applicant's Sibley Wind substation in Section 12 of Cornish Township. Electricity will be stepped up to 69 kilovolts (kV) at the Sibley Wind Substation and delivered to the high voltage transmission system via an existing 69 kV line. Other associated facilities will include pad mounted step-up transformers and turbine access roads.

#### **Proposed Site Location**

The proposed Sibley County Wind Project is located in Sibley County, approximately 1- 3 miles west and southwest of Winthrop, Minnesota. The site comprises approximately 2,100 acres in portions of eight sections in Cornish Township. The Applicants anticipate that approximately 10 - 12 acres of land would be permanently removed from agricultural production for turbine sites, access roads and the Project substation.

#### **MPUC Site Permit Review Process**

Sibley Wind Substation, LLC, a Minnesota based corporation, submitted a site permit application for the 20 MW Sibley County Wind Project on April 24, 2008. On May 22, 2008, the PUC accepted the applications as complete, made a preliminary determination that a permit may be issued and issued a draft site permit. The

application and draft site permit are available from the web site and contacts listed below. Landowners and governments within the Project boundary will receive a copy of the application directly Sibley Wind Substation, LLC.

The OES is now initiating the public participation process under the Wind Siting Act (Minnesota Statutes Chapter 216F) and the Wind Permitting Rules (Minnesota Rules Chapter 7836). Upon completion of the public participation process, the OES will present the record of this matter to the PUC for a final permit decision.

#### **Contested Case Hearing Request**

Any person may request a contested case hearing in this matter (Minnesota Rule 7836.0900). All contested case hearing requests must be filed with the Department of Commerce in writing by 4:30 p.m. on **July 30, 2008**. The person requesting the contested case hearing must list the issues to be addressed in the hearing and the reasons why a contested case hearing is required to resolve those issues. The PUC shall order a contested case hearing if it finds that a material issue of fact has been raised and that the holding of the hearing will aid the PUC in making a final decision on the site permit application and draft site permit.
