Project description: The Bruening Rock Products Pierce Quarry is a proposed aggregate and sand quarry to be excavated for local construction and agricultural uses. An Interim Use Permit is required by the City of Pine Island for mining sand and gravel within the

Agricultural zoning district. The cumulative area of the proposed operation identified the requirement for this EAW.

Klondike Clean Water Retention Project

Location: Lancaster, Kittson and Roseau Counties **Process:** Environmental assessment worksheet (EAW)

Project description: The Klondike Clean Water Retention Project (KCWRP) is a multipurpose public project of the Two Rivers Watershed District developed under MN Statute 103D. It is proposed to provide both flood damage reduction and natural resources enhancement components. Located in Roseau and Kittson Counties and within the Two Rivers and Red River watersheds, it is anticipated the project will reduce flooding, improve water quality, improve aquatic habitat, protect and enhance a prairie rich fen, and provide an adequate drainage outlet primarily for lateral 1 of State Ditch 95 and secondarily for State Ditch 72.
