

## Big Bend Wind Project, Associated Transmission Line, and Red Rock Solar Project

**Notice Description:** The Public Utilities Commission will hold in-person public hearings and a remote-access public hearing on the applications of Big Bend Wind, LLC and Red Rock Solar, LLC, both affiliates of Apex Clean Energy Holdings, LLC for two certificates of need, a LWECS Site Permit, a Solar Site Permit, and an HVTL Route Permit. The Department of Commerce has completed and made available an Environmental Assessment for the proposed projects being considered for need and permitting by the Commission.

**Project Description:** The amended Big Bend Wind Project will generate up to 300 MW of electricity with 45 to 47 turbines, gravel access roads, underground and/or above ground electrical collection and communication lines, one O&M facility, a project substation, up to one meteorological tower, a SODAR or LIDAR unit, up to four Aircraft Detection Lighting System radars, and one temporary batch plant area. The Red Rock Solar Project will generate up-to 60 MW solar energy on approximately 483 acres of land in Cottonwood County. The facility will include photovoltaic panels installed on a tracking rack system, electrical inverters, an electrical collection system, fencing, access roads, up to three weather stations, a project substation, and 10 stormwater drainage basins. A 161 kV transmission line will interconnect the Big Bend Wind and Red Rock Solar Projects to the transmission grid. The proposed HVTL will be located in Cottonwood, Watonwan, and Martin Counties.
