New Environmental Review Projects Database


We are pleased to present our new database which can be found at the Environmental Review Projects Database <u>webpage</u>. The searchable database allows you to find information about projects noticed in the *EQB Monitor*. Each project page contains all environmental review documents and decision documents from the project, and the documents can be downloaded. The search function and map within the database allows you to locate projects by location, environmental review type and process, or mandatory category.

Database features

- Search functionality increasing users' ability to find projects that have completed environmental review or are currently undergoing the process
- Permanent access to all environmental review documents from each project
- Library of usable information regarding past environmental review projects

Please note, the database will house all environmental review projects noticed in the *EQB Monitor* since the launch in May of 2023.
