Project Description: Lexington Waters Residential Development will include up to 176 single-family homes, 120 detached townhomes, municipal streets, stormwater basins, wetland preservation, and parkland on 115.45 acres in eastern Anoka County. Site development will involve mass grading, connections to municipal sewer and water, and excavation of stormwater basins.

JD 14 - Lilac Ridge Water Management Project

Location: Viking, Minnesota/Viking and New Solum Townships, Marshall County

Process: EAW

Step: Completed EAW Available

End of Comment Period: July 29, 2021

Project Description: The Middle-Snake-Tamarac Rivers Watershed District in an effort to improve flood protection within the Judicial Ditch (JD) 14 sub-watershed proposes the construction of the Lilac Ridge Water Management Project which consists of an off-channel impoundment located primarily in the north ½ of Section 1 in Viking Strip Township along with grade stabilization of approximately 3 miles of JD 14 Main Branch within the Lilac Ridge area. The Lilac Ridge Road structure is proposed to increase from a single line of 60-inch pipe to 3-lines of 72-inch, and the inverts lowered approximately 5-feet to the proposed ditch grade. A earthen inlet weir will direct high flows into the impoundment site approximately one mile west of Lilac Ridge Road. Low flow would continue down JD 14 through a 60-inch piped crossing just downstream of the earthen inlet weir. The impoundment site would also include an outlet riser structure to release flows back into the JD 14 system once downstream conditions subside.
