

Lake Traverse Water Quality Improvement Project - Phase II

Comment Deadline: April 15, 2021

Project Description: The Bois de Sioux River Watershed is proposing to complete the Lake Traverse Water Quality Improvement Project (LTWQIP) Phase II of a multi-phase project to improve water quality, reduce sedimentation, reduce flooding and improve fish habitat through restoration of Traverse County Ditch 52 (TCD 52), a main tributary to Lake Traverse in the Bois de Sioux watershed. Phase II consists of channel stabilization improvements and habitat enhancement on the TCD 52 tributary from immediately downstream of Minnesota State Highway 27 to the outlet at the confluence with TCD 52, approximately 1,500 feet of channel.

Hiawatha Maintenance Facility Expansion (comment period extended)

Comment Deadline: March 25, 2021

Project Description: This EAW studies the proposed Hiawatha Maintenance Facility Expansion located at 1911 East 26th Street, 1860 East 28th Street and 2717 Longfellow Avenue in Minneapolis. The Minneapolis Public Works Department is proposing to expand their Hiawatha Maintenance Facility, located at 1911 East 26th Street, into the property immediately to the south. This will involve the relocation and consolidation of water distribution maintenance office, shop, yard and vehicle/equipment storage functions, and sewer and stormwater office staff from elsewhere, requiring the demolition of the former Roof Depot warehouse building, and construction of approximately 328,000 square feet of new buildings, and parking (surface and structured) for an additional 360 City and personal vehicles.

PLEASE TAKE NOTICE that the Minnesota Public Utilities Commission (Commission) will hold a remote-access public meeting on the application of Petroleum Fuels Company (PFC) for its proposed gas pipeline project. Due to the current COVID-19 pandemic, the remoteaccess public meeting will replace the standard in-person meeting. Similar to an inperson meeting, the remote-access meeting will provide interested persons the opportunity to: (1) provide comments regarding the proposed project; and (2) ask questions and provide comments on potential issues to be considered by the Commission in its decision-making process or included as a condition in the final route permit.

How to Attend the Meeting

To participate, follow the directions below to access the meeting over the telephone to listen and/or provide verbal comments (audio only). If you are also interested in accessing the video portion of the meeting, follow the directions below to view the presentation over the internet (video only – no audio). You must, at a minimum, join the meeting by telephone if you are interested in listening to the meeting and/or in providing verbal comments on the proposed project. If you wish to watch the video stream with audio you must join by both phone and internet. Written comments may also be submitted during the comment period following the meeting using the methods described in this notice.

Project Description

The proposed project would include construction of a new 4.5-inch steel pipeline, approximately 5,600 feet in length, in Inver Grove Heights, MN. The proposed pipeline will transport gas from a Renewable Natural Gas Processing Facility near the Republic Services Pine Bend Landfill to a delivery point into the Northern States Power Company high-pressure gas system. The pipeline will operate at a pressure of 670 pounds per square inch gauge.

PFC filed its application under the Commission's partial exemption review process. The partial exemption review process is applicable to pipeline projects that are not anticipated to have significant environmental impacts. The partial exemption process is outlined in Minn. Rule 7852.0600 and applications are reviewed under the evaluation criteria outlined in Minn. Rule 7852.0700.

The Commission will decide whether to grant or deny the partial exemption based upon public comments received, the information in the record, and the criteria set forth in Minnesota Rule 7852.0700, Subp. 3. If the Commission does not grant the partial exemption, PFC may submit its application pursuant to the Commission's full pipeline route selection procedures.

Meeting Information

The purpose of the public meeting is to inform the public about the project, to obtain public input on the proposed project, and to compile the record for the Commission to consider in making a final decision on the route permit application.

- The meeting starts on time.
- Log in/dial in a few minutes before the scheduled start time.
- Public Utilities Commission, Department of Commerce, and PFC representatives are available to answer questions about the permitting process and the project.
- You may provide verbal comments or ask questions.

- What potential human and environmental impacts of the proposed project should be considered?
- What are the possible methods to minimize, mitigate, or avoid potential impacts of the proposed project?

- Should the Commission grant or deny the partial exemption requested by PFC?
- Are there other project related issues or concerns?

Important: Comments will be made available to the public via the Public Utilities Commission's website, except in limited circumstances consistent with the Minnesota Government Data Practices Act. The Commission does not edit or delete personal identifying information from submissions.

Process Information

Before a pipeline can be constructed, the Commission must issue a route permit for the project. PFC's partial exemption application was accepted as complete by the Commission on February 23, 2021. The Commission's partial exemption permitting process takes about 90 days.

The public information meeting is intended to inform the public about the permitting process, to compile information to assist the Commission in determining whether to grant or deny the partial exemption application, and to afford an opportunity for members of the public to submit comments. In deciding whether to grant or deny the partial exemption, the Commission will consider comments filed, the information contained in the application, and the record as a whole relevant to the criteria for a partial exemption. If the Commission grants a partial exemption, it will issue a pipeline route permit.
