**Notice Description:** Please take notice that the Minnesota Public Utilities Commission will hold a remote-access public hearing and an in-person public hearing and on the applications of Hayward Solar LLC, for a certificate of need and a site permit for an upto 150 megawatt, solar energy generating facility in Hayward Township in Freeborn County. Written comments will be received through Friday, April 15, 2022, at 4:30 PM. Please focus your comments on information that will help answer the following questions: Is the proposed project needed and in the public interest? What are the potential human and environmental impacts of the project, and how can these impacts be addressed in the site permit? Should the Commission issue a certificate of need for

the proposed solar energy system? Should the Commission grant a site permit for the proposed solar energy system? If granted, what additional conditions or requirements should be included?

Project Description: The Hayward Solar Project would generate up-to 150 megawatts of solar energy within an approximately 1,970-acre project area located east of the city of Hayward and south of Interstate 90. Solar equipment and supporting infrastructure are expected to occupy about 1,270 acres within this area. The proposed project would use photovoltaic solar panels, mounted on linear tracking systems. Underground collection lines would route the electric power to a proposed switching station on the existing Hayward-Murphy Creek 161-kilovolt HVTL. The switching station would be constructed, owned, and operated by the Southern Minnesota Municipal Power Agency. Hayward Solar, LLC anticipates the proposed project become operational in 2023.
