CSAH 35 Improvements

Location: Sverdrup Township, Otter Tail County

Project Description: Otter Tail County proposes to reconstruct approximately 3.14 miles of County State Aid Highway (CSAH) 35 between CSAH 18 and CSAH 1. The roadway will be reconstructed from two 11-foot lanes and 1.5-foot gravel shoulders to 12-foot lanes, 4-foot paved shoulders, and 1.5-foot gravel shoulders. Road inslopes will also be corrected along the length of the project. Near the south end of the project, the road will be raised approximately 2.0-feet to alleviate flooding issues. Right-turn lanes will also be added at CSAH 18 and CSAH 1.

Knife River Honer Aggregate Mine

Location: Saint Augusta, Stearns County Process: EAW Step: EAW Available

Project Description: Knife River is proposing to construct a 66.5-acre nonmetallic mineral mine, producing construction sand and gravel, located in the City of Saint Augusta, Stearns County. This project will take place on three parcels totaling 161 acres, with mining limited to the 66.5-acre area. The proposed Mining Area currently is tilled agricultural fields and some wooded area. Access to the Mining Area will be off of 28th Avenue, south of where it intersects with CR-7. This project will provide aggregate materials for use in local construction projects both public and private. No permanent structures are proposed.
