## **Dale Properties Lakeville Residential Development**

**Project description:** The EAW for the Dale Properties Lakeville Residential Development includes review of approximately 132.6 acres of land in Lakeville, northwest of I-35E and 205th Street West. The project will include development of 805 multiple family residential units on 32.3 acres, 117 single family residential units on 32.9 acres, 118 medium density residential units on 33.4 acres, and over 9 units/acre of neighborhood commercial and senior housing on approximately 16.3 acres. The remaining acreage will

be wetlands, grasslands, and stormwater areas. Site development will include grading and installation of municipal sewer and water, streets, and stormwater systems.

## Byron Solar Project

**Notice title:** Notice of Environmental Assessment Scoping Decision

**Notice description:** The Minnesota Department of Commerce has issued the scope for the environmental assessment to be prepared for the proposed Byron Solar Project in Dodge and Olmsted counties. In addition to the applicant's proposed site and route, the EA will evaluate one additional route alternative for the proposed 345 kV transmission line. The Department anticipates the EA will be available for review in late September 2022.

**Project description:** Byron Solar, LLC (Byron Solar) proposes to construct a 200 megawatt (MW) solar generating facility on approximately 1,800 acres in Canisteo and Mantorville townships in Dodge County. The project also includes construction of approximately 3-4 miles of 345 kV high voltage transmission line in Dodge and Olmsted

counties to connect the solar facility to the transmission grid at the Byron Substation, located just west of the city of Byron in Olmsted County.
