Board establishes Subcommittee for Pilot Program Implementation and approves 2021 Annual Pollinator Report

At the November 2021 Environmental Quality Board (EQB) meeting, the EQB passed a resolution to establish a subcommittee for a <u>pilot program</u> to steer implementation of the draft revised Environmental Assessment Worksheet (EAW). The purpose of the pilot program is to assess the efficiency and effectiveness of climate information included on the draft revised EAW. The Board also approved the <u>2021 Minnesota State Agency Pollinator report</u>, which highlights goals, challenges, and actions for pollinator protection. Blue Stem North Residential Development

Project Description: The Blue Stem North residential development is proposed on 15.3 acres of vacant upland in an area known as the Golden Triangle in northeastern Eden Prairie. The project is adjacent to the Southwest LRT Golden Triangle Station. The proposed project would include three buildings ranging from 4 to 6 stories with a total of 425 housing units and structured parking along with complimentary interior and exterior amenity spaces. Approximately 11.3 acres of the 15.3 total is planned as open space, which will include trails, wetlands and buffers, woodlands, and a stormwater pond.

Lake Shamineau High Water Outlet Project

Location: Scandia Valley Township, Morrison County and Fawn Lake Township, Todd

County

Project Description: Lake Shamineau's water level has risen to a high of approximately 2.9 feet above the Ordinary High Water Level (OHWL) in recent years and is presently more than 1 foot above the OHWL, resulting in flood damages to properties and infrastructure and causing severe shoreline erosion. To alleviate damage, the Lake Shamineau Lake Improvement District (LSLID) proposes to construct an outlet structure, pump station, and underground pipe as well as ditch excavation to restore the lake's water levels closer to the OHWL. The proposed project will include Scandia Valley Township of Morrison County and Fawn Lake Township of Todd County. The project corridor is located along the southwest shoreline of Lake Shamineau and the ditches along Aztec Road, US Highway 10, County Road 203, Atlantic Road, and Pulaski Road.

Munger Landing Sediment Remediation

Project Description: The Minnesota Pollution Control Agency, in partnership with the U.S. Environmental Protection Agency and the Wisconsin Department of Natural Resources, will conduct an environmental cleanup at Munger Landing in the St. Louis River Area of Concern. The project consists of dredging approximately 100,000 cubic yards of contaminated sediment, temporarily storing and dewatering the sediments offsite, disposing of the dewatered sediments at a certified offsite landfill, placing a residual cover of clean sediment over the dredged area, and revegetating the site post construction.
