Upper South Branch Buffalo River Restoration Project

Project Description: In an attempt to improve water quality, channel conveyance, and habitat, while reducing flooding and sedimentation, the Buffalo-Red River Watershed District proposes to complete channel restoration using natural channel design principles, install expanded buffer strips along the South Branch Buffalo River, and install side water inlets and other sediment control BMPs within the South Branch Buffalo River Watershed. An EAW has been prepared and is available for review on the BRRWD website (www.brrwd.org). Written comments concerning the EAW will be received until November 11, 2021. The comments shall address the accuracy and completeness of the material contained in the EAW, potential impacts that may warrant further investigation before the project is commenced, and the need for an Environmental Impact Statement on the proposed project.
