Project Description: The proposed Victoria Shores Residential Development project would entail the development of approximately 6.75 acres within the city of Roseville, MN. The proposed project is located generally at the intersection of Victoria Street and Orchard Lane, and includes frontage on the southwest shore of Lake Owasso. The project proposes the development of eight single-family units on three vacant lots, including creation of four riparian lots with private-use docks, with the remaining four lots utilizing a joint-use dock.

The proposed project is a transit-oriented, mixed-use development that will include residential, commercial, recreational opportunities associated with the Minnehaha Creek, and regional stormwater management.

Northern Con-Agg - Boen Pit

Location: Luverne Township, Rock County

Project Description: Northern Con-Agg, LLP proposes mining the gravel resources on the Tor Boen property, located in the W 1/2 of Sec. 1 of Luverne Twp. The mine is to approximately 92 acres in size. The gravel from the site will be conveyed by belt conveyors to an adjacent site, located to the north for processing. Mining onsite is to be done over a period of approximately 15 to 20 years and will be done in 3 phases so only a portion of the mining area will be disturbed at any given time. The first step is to remove the overburden above the gravel using excavation equipment. Berms will be constructed on the west side of the property providing visual and sound screening. Gravel will be removed by use of hydraulic dredging equipment, to approximately 30 to 35 feet below the surface. Reclamation will be performed as phases are completed with slopes at minimum of 18 percent, with a minimum of 4 inches of topsoil and revegetated as per MnDNR's "Handbook for Reclaiming Sand and Gravel Pits in Minnesota."

Nelson Slough Improvement Project

Location: Strandquist, Minnesota/Lincoln and East Park Townships, Marshall County

Project Description: The Nelson Slough Improvement Project proposes stabilizing several miles of Judicial Ditch 19 (JD 19) and improving structures within Nelson Slough, including replacement of the 50-year-old outlet structure and increasing the height of the embankments. Installing rock drop structures and flattening channel side slopes in strategic locations would improve slope stability and alleviate severe channel erosion that has occurred immediately upstream and downstream of the site. Upon completion, the proposed project would reduce potential flood damage to adjacent agricultural lands and public transportation infrastructure. The project would also provide more control over impoundment water levels, improving wildlife habitat at Nelson Slough.

Project Description: The Brooklyn Park Gateway Alternative Urban Areawide Review (AUAR) examines 125.0 acres of land in Brooklyn Park to analyze the impacts and mitigation measures necessary to accommodate a mixed-use development. The City of Brooklyn Park adopted the Brooklyn Park Gateway Final AUAR and Mitigation Plan on January 26, 2016. The study area is generally situated in the southwest quadrant of the Trunk Highway 610 and US Highway 169 interchange, with the western and southern study area boundaries defined by Jefferson Highway North and 93rd Avenue N (CR 30) respectively.

Louise Solar Project

Notice Description: On February 11-12, 2021, Louise Solar Project, LLC (Applicant) submitted applications to the Minnesota Public Utilities Commission to construct and operate a 50-megawatt (MW) solar energy generating system in Mower County. In order to construct the Louise Solar Project, the Applicant must be granted a certificate of need and a site permit from the Commission. The proposed project area is comprised of approximately 613 acres of agricultural land located in Lodi and Adams Townships in Mower County, of which the final project design is expected to occupy approximately 325 acres. Minnesota Department of Commerce Energy Environmental Review and Analysis issued an environmental assessment on the project on September 27, 2021.

Project Description: In addition to the photovoltaic solar panels mounted on a linear axis tracking system, the proposed project would consist of inverters, step-up transformers, electrical cables and conduits, electrical cabinets, access roads, a 34.5/161- kilovolt (kV) step-up substation with metering and switching gear, security fencing, below-ground or above-ground electrical collection and communication lines, an operation and maintenance facility, parking lot, up to four weather stations, a 161-kV overhead transmission line (under 1,000 feet in length), a supervisory control and data acquisition system, and temporary laydown areas. The project would interconnect at the existing ITC Midwest Adams Substation in the project area. The Commission accepted the certificate of need and site permit applications in May 2021. This means the Applicant submitted all the information required to begin the review process.

After the public hearing and comment period, Administrative Law Judge Barbara Case will prepare a report including findings of fact, conclusions of law, and a recommendation for the Commission. The Commission will review all the information in the record, including comments submitted by the public and anticipates final decisions on the applications by spring of 2022.
