## EQB announcement



Board approves resolution to pilot inclusion of climate information in EAW

At the September 2021 Environmental Quality Board (EQB) meeting, the EQB passed a resolution to implement a pilot program for evaluating the revised draft Environmental Assessment Worksheet (EAW) that includes climate change information. The draft revised EAW includes items for greenhouse gas quantification and assessment as well as

adaptation and resiliency information. The resolution directs staff to report the results of the pilot program and provide a revised EAW form for Board action no later than December 2022.
